# **Consultation Plan**

for the development of the CRDC 2023-2028 Strategic Plan

#### Introduction.

The Cotton Research and Development Corporation (CRDC) leads investment in cotton research, development and extension (RD&E) for the Australian cotton industry. A partnership between the Australian Government and cotton growers, CRDC exists to invest in, and deliver outcomes from, world-leading RD&E to benefit Australia's dynamic cotton industry and the wider community.

We invest in innovation and transformative technologies to deliver impact, and as an organisation we are ambitious, agile, and adaptive.

Cotton is a major contributor to the economic, environmental and social fabric of rural Australia. The industry's national exports generate an average of \$1.9 billion in annual revenue, and the industry is a major employer in rural and regional communities.

Despite prolonged dry seasonal conditions across many of the cotton growing valleys, and the challenges associated with COVID-19, the industry continues to go through a period of geographic growth. The industry continues to expand from its predominant growing base in New South Wales (NSW) and Queensland (QLD) into northern Victoria (VIC), the Northern Territory (NT) and Western Australia (WA).

RD&E and its resulting innovations are a key driving force behind our industry's continued success, and CRDC's purpose is to power the success of Australian cotton through this world-leading RD&E.

This RD&E investment is governed by a five year Strategic R&D Plan. The development of the new CRDC Strategic R&D Plan, for the period 2023-2028, is underway.

### Purpose.

The purpose of this Consultation Plan is to outline the approach that CRDC is taking in consulting and engaging with stakeholders in relation to the development of the new Strategic RD&E Plan.

The CRDC Strategic R&D Plan 2023-28 will guide all CRDC investments in cotton research, development and extension (RD&E) over this period, in line with the Cotton Sector RD&E Strategy and the industry and Government priorities.

As detailed in this plan, a series of consultation and engagement activities will be undertaken throughout 2022 and 2023, to seek stakeholder input and feedback. The information gathered during this consultation will be used to inform the development of the CRDC Strategic RD&E Plan, including the objectives, target outcomes and measures of success.

The purpose of the industry consultation is fourfold:

- 1. Providing context and coordinating approaches: Facilitating a discussion of the future direction of the Australian cotton industry that can help inform and align organisational strategic planning within the sector.
- 2. Providing opportunity for grower input to overall industry strategic direction: Providing



- every grower with the opportunity to contribute to the strategic direction of the industry, CRDC, and the CottonInfo extension program.
- 3. Providing opportunity for other stakeholders input to CRDC's strategic direction: Providing CRDC's key government, industry and research stakeholders with the opportunity to contribute to the strategic direction of CRDC.
- 4. Providing input into the CRDC Strategic RD&E Plan: Enabling shared expectations between CRDC and its grower stakeholders in contributing to the development and approval of CRDC's new five year Strategic RD&E Plan 2023-28.

### Stakeholders.

CRDC will work collaboratively with its stakeholders in the development of the Strategic RD&E Plan. Through the consultation and engagement activities, CRDC will engage with:

- Australian cotton growers;
- Cotton Australia, the Cotton Australia research advisory panels and Cotton Grower Associations;
- The Department of Agriculture, Water and the Environment and the Minister for Agriculture and Northern Australia;
- The Cotton Innovation Network and the Australian Cotton Industry Forum;
- Cotton research partners, including CSIRO, the NSW Department of Primary Industries, the Qld Department of Agriculture and Fisheries, universities and the private sector;
- Other industry bodies and partners, including CSD, CottonInfo, Crop Consultants Australia, the Australian Cotton Shippers Association, and the Grains Research and Development Corporation.
